Migration and Human Trafficking: Tracing Root Causes & Seeking *Intensional* Solutions

MODULE 1

DELIMITING THE PROBLEM FROM ORIGIN TO DESTINATION ASSESSING HUMAN TRAFFICKING IN THE CONTEXT OF MIGRATION

During this interactive, three-part Module facilitated by expert instructors, Prof. Dr. Roza Pati and Attorney Ana Vallejo, participants will delimitate the problem of human trafficking in the context of migration. Through a critical examination of case studies, participants will fully engage in discussions aimed to thoughtfully define the problem of human trafficking – from a migrant’s origin to destination. Foundational principles will include:

Part I	<i>The push and pull factors that cause people to migrate to the U.S. and the vulnerabilities that are associated.</i>
Part II	<i>How traffickers use push and pull factors to exploit people on the move into human trafficking.</i>
Part III	<i>The various ways people on the move to the U.S. are exploited into human trafficking as presented through an assessment of diverse case studies illustrating forced labor, domestic servitude, sex trafficking, debt bondage, and other forms of exploitation.</i>

MODULE 2

AT DESTINATION PART I: LAW AND POLICY ON THE BOOKS

At Destination Part I examines the federal law and policies on the books affecting migrants who come to the United States. Participants will gain a solid understanding of the detention process at the southern border, various sponsorships systems for migrants, and the accessibility and adequacy of various protections in law available to refugees and survivors of human trafficking.

MODULE 3
AT DESTINATION PART II: ENFORCEMENT AND COMPLIANCE ISSUES

At destination, law and policy as written may seem to be well-defined. However, multiple issues surround the realities of procedure, compliance, and enforcement of the law in action. *At Destination Part II*, explores how the law on the books is implemented, and how it in turn may be impacted by the fluctuating enforcement and compliance issues. Through this lens, participants will comprehensively examine processes and infrastructure in place, the systems that support law and policy – whether through public or private organizations, through human and financial resources, or lack thereof.

MODULE 4
THE MISSION OF ACCOMPANIMENT: BUILDING THE PATH OF DEVELOPMENT WITH SURVIVORS, MIGRANTS, AND REFUGEES

As survivors, migrants, and refugees are encountered, what is integral to their path of development? This Module discusses the mission of accompaniment: welcome, protect, promote and integrate migrants in the life of society at the destination country, working together to build the future of those who come as an integral part of the future of the hosts. This Module will also include a special session examining the state of Ukrainians in the U.S. who were forced to flee war.

MODULE 5
**INTENSIONAL SOLUTIONS:
DEVELOPMENT TOWARDS A WORLD FREE OF MODERN SLAVERY**

The final Module consists of three distinct Working Groups aimed at developing *intensional* solutions to problems examined throughout the week. During these plenary sessions, Working Groups comprised of leading experts in the field will discuss pressing challenges facing the United States such as the future of unaccompanied children; gaps in policies and services facing survivors of human trafficking; and gaps in labor practices and respective protections, as well as the role of worker-driven responsibility.
